

Information clause on the processing of personal data

Information on the processing of your personal data

Polish Jockey Club (hereinafter also referred to as "PKWK") hereby informs you that your personal data are processed by PKWK. Details of this processing are listed below.

I. Personal data administrator

The Administrator of your personal data is Polish Jockey Club with its seat in Warsaw.

II. Data Protection Officer

PKWK has indicated a Data Protection Officer, who you can contact in matters of the protection of your personal data processed by PKWK and in matters of executing your rights. Contact with the Data Protection Officer is possible by e-mail: ochronadanych@pkwk.org or in writing to the address of the seat of the PKWK: Warsaw (post code: 02-684), ul. Puławska 266, with the note "IOD".

III. Purposes and legal basis of personal data processing

- In order to properly performing the tasks imposed on the PKWK in the Act of 18 January 2001 on horse racing (Journal of Laws of 2017, item 194, as amended) and in executive acts to this Act or in other normative acts adopted on its basis, based on your consent (the basis of Article 6 item. 1 point a) of the Directive 95/46/EC (General Data Protection Regulation – hereinafter referred to as "RODO Directive")
- In order to execute and on the basis of the contract you have concluded with PKWK (the basis of Article 6 item 1 point b) of the RODO Directive),
- In order to archive (evidentiary) purposes to secure information in the event of a legal need to indicate facts, which is the legitimate interest of the PKWK (the basis of Article 6 item 1 point f) of the RODO Directive),
- In order to possibly determine, investigate or defend against claims, which is the legitimate interest of the PKWK (the basis of Article 6 item 1 point f) of the RODO Directive).

IV. Categories of personal data processed by PKWK (it is provided when personal data was obtained not from the person to whom it relates).

V. Recipients of personal data

PKWK may share your personal data with the following entities / categories of entities:

- subcontractors, i.e. entities whose services PKWK uses when processing them, such as accounting, law and IT companies, claims adjusters, marketing agencies, etc.];
- other independent recipients, e.g. competent state institutions, on the basis of relevant provisions of generally applicable law.

VI. Transfer of personal data to third countries or international organizations

PKWK does not transfer your personal data outside the territory of the Republic of Poland / European Union / European Economic Area.

VII. Data Retention Period

Your basic contact details are stored by PKWK for the proper performance of the obligations imposed on PKWK which are indicated in the Horse Racing Act or resulting from the PKWK statutory objectives, until you make object due to processing data or you withdraw your consent, if PKWK processed them on the basis of a specific consent, or PKWK considers that these data have become outdated.

If your data was obtained by PKWK in connection with the conclusion of the contract, it would be stored by PKWK until the end of the limitation period for potential claims resulting from such a contract.

VIII. Your rights

You have the following rights related to personal data:

- the right to access your data and receive a copy of it,
- the right to rectify (correct) your data,
- the right to delete data (if in your opinion there are no grounds for PKWK to process your data, you can request their removal),
- restrictions on data processing (you can request that PKWK limit the processing of your personal data only to their storage or performing activities agreed with you, if in your opinion PKWK has incorrect data about you or processes it unreasonably, or you do not want PKWK to delete it, because you need them to establish, pursue or defend claims, or for the time you object to data processing,
- the right to make objection to data processing on the basis of a legitimate interest and where data processing is necessary for the PKWK to perform a task carried out in the public interest or for PKWK to exercise public authority entrusted to the PKWK. In this case, please indicate to PKWK your particular situation, which in your opinion justifies PKWK's cessation of processing the data covered by your objection. PKWK will stop processing your personal data for these purposes, unless it demonstrates that the grounds for processing your data prevail over your rights or that your data is PKWK necessary to establish, assert or defend claims,
- right to data portability: you have the right to receive from PKWK in a structured, commonly used machine-readable format (e.g. CSV format) personal data about you that you have provided to PKWK on the basis of a contract or your consent. You can commission PKWK to transfer this data directly to another entity,
- the right to lodge a complaint with a supervisory authority: if you think that PKWK is processing your data unlawfully, you can file a complaint to the President of the Office for Personal Data Protection or to another competent supervisory authority,
- the right to withdraw consent to the processing of your data: you have the right to withdraw your consent to the processing of data by PKWK at any time. Withdrawal of consent will not affect the lawfulness of data processing that was made on the basis of your consent before its withdrawal.

In order to implement the above rights, the request should be made directly to the e-mail address ochronadanych@pkwk.org or by post to the address of the seat of PKWK. Please note that before implementing the abovementioned permissions PKWK is required to identify your identity.

IX. Information on the requirement / voluntary provision of data

- Providing personal data is / can be:
- a statutory requirement arising from the Horse Racing Act and the Labor Code;
- a condition for concluding an agreement with PKWK,
- a contractual requirement arising from the contract you conclude with PKWK,
- optional.

If you do not provide personal data to PKWK:

- PKWK may refuse to conclude a contract with you, examine the application, etc.,
- PKWK may refuse to provide benefits.
