## Basic information for participants

### Information for Participation in Horse Racing Activities in the Czech Republic for Foreigners:

Horse racing activities are governed and overseen by the Jockey Club of the Czech Republic (JCCR), legal form: Association, Organisation ID No. 41186532, VAT ID No. CZ41186532

### REGISTRATION, ANNOUNCEMENT OF STARTING HORSES, AND DECLARATIONS OF JOCKEYS

All entries and confirmation of starts are carried out via the JCCR. The deadline for entries, or if necessary forfeits, is always 12 noon on the appropriate day according to the instructions, and the deadline for announcing starting horses is always 10 a.m. on the appropriate day according to the instructions. At the same time as entering a horse into a race at the latest, the person registering the horse shall submit the complete career of the horse together with its current handicap (rating) – both confirmed by the appropriate racing authority, and no later than the deadline for announcing starting horses, shall submit an RCN. In the case of horses starting in the Czech Republic for the first time, a completed form and career of the horse must be submitted at least three days before the deadline for entries. This shall not apply to horses registered in Slovakia unless they have competed in races outside Slovakia and the Czech Republic.

Foreign owners of horses trained in the Czech Republic shall be considered tax residents of the Czech Republic, unless treaties for the avoidance of double taxation stipulate otherwise.

Before their first engagements in the Czech Republic in a given year, together with a completed form, jockeys **are obliged** to submit a **Clearance** confirmed by the appropriate racing authority which issued them with a licence.

All forms must be filled in carefully, completely, legibly and in good time. Applicants are responsible for ensuring that the information they provide is accurate and complete.

If the required information is not provided, or the information is inaccurate (particularly as regards addresses, VAT payer numbers and tax domiciles), the applicant acknowledges that it is not possible to correct already issued payments and, therefore, invoices retrospectively.

Forfeiting a horse from a race must be notified in writing (by e-mail or fax). In the case of a late cancellation of a start, the horse shall remain in the race and the owner of the horse shall be billed for the entrance fee in accordance with the instructions.

If the applicant fails to confirm a horse on the starting list, the horse shall be considered forfeited and the starting fee shall not apply.

#### Payment and Billing

All financial transactions connected with horse racing activities in the Czech Republic shall be carried out via the JCCR Accounting Centre

Each person participating in horse races based on registration in a horse race (owner, trainer, jockey) will have an account set up at the Accounting Centre – based on the completion of the relevant form (see Article I. "Forms"). It is not possible to compete in horse races without setting

up an account with the Accounting Centre. The information provided in the account of a participant in horse races serves as a basis for billing, issuing payments and transferring winnings.

Each race participant shall be charged an annual account fee by the Accounting Centre:  
owner, trainer: CZK 600.00, or CZK 726.00 incl. VAT  
jockey: CZK 500.00, or CZK 605.00 incl. VAT

After the end of each regular month during which transactions are carried out in their account, each participant in horse racing activities will receive a balance statement and any potential invoices by post (or e-mail). All participants can keep track of "their" account kept at the JCCR Accounting Centre on the JCCR website, if they request a password for their account.

## **Winnings and Riding Fees**

### **Horse Race Prizes**

The distribution of the prize from a horse race and the amount of riding fees is governed by the Racing Rules of the JCCR, in accordance with additional provisions.

The owner of the horse will receive 85 % of the prize from a horse race, the trainer 10 % and the jockey 5%. The amounts will be automatically credited to the appropriate accounts at the JCCR Accounting Centre within 48 hours of the official announcement of the results after the race. The transfer of winnings may be delayed longer than the absolutely necessary time if the horse is selected for drug testing, or if protests or appeals have to be resolved.

Due date for winnings:

If owners, jockeys or trainers fail to prove their tax domicile in good time, withholding tax shall be deducted from their winnings in the sum of 15% if they are based in EU or EEA countries, or 35% in other cases. Amending regulation: Section 36 of Act No. 586/1992 Coll., the VAT Act, as amended.

Before potential taxation, withholding tax in the sum of 5% shall be deducted from the winnings of owners of a horse trained abroad. This sum shall be retained by the JCCR to support horse racing activities.

Foreign owners of horses trained in the Czech Republic: in this case, owners are considered to be tax residents of the Czech Republic, unless treaties for avoidance of double taxation stipulate otherwise.

### Riding fees (in CZK):

- a) Flat races – jockey:  
700.00 (race categories III.-V.)  
900.00 (race categories I. and II.)  
Double these rates in the event of a win.
- b) Jump races – jockey:  
800.00 (race categories III.-V.)  
1,000.00 (race categories I. and II.)  
Double these rates in the event of a win.

Riders may agree a riding fee exceeding the scope of the official fees, however payment of such a fee shall not be carried out through the Accounting Centre.

- c) Withdrawals from an account

Money is not automatically paid out of an account, so a withdrawal must be requested. Money is sent to the bank account specified when setting up an account with the JCCR Accounting Centre (the IBAN, SWIFT and the name and seat of the bank must be included in the Application form). ### **Stabling**

Stabling falls under the responsibility of individual organisers and is billed via the Accounting Centre. Each organiser has its own price for stabling. Stabling with organisers who are VAT payers is always billed with VAT (as with services connected with the use of real estate / rent, this service is not subject to the reverse charge procedure).

### **Debtors**

All participants in horse racing activities, especially owners, are obliged to have sufficient funds in their account with the Accounting Centre to be able to cover their commitments in a timely manner. Negative account balances are not permitted. All participants can monitor the current balance of their accounts via the website, can verify it by making an enquiry at the Accounting Centre, or can request that it be sent to them. **Owners who have insufficient funds in their accounts shall be excluded from races without compensation and shall be obliged to settle any amounts owed without delay.** Any owners, trainers and jockeys who appear on the List of Debtors shall be prohibited from competing in horse races in the Czech Republic.

### **Accounting Centre**

The Accounting Centre merely mediates financial flows in horse racing activities between horse owners, jockeys, trainers and organisers, and potentially other authorities (tax offices) based on information provided by these. In view of the fact that the Accounting Centre is used for organisers to bill and pay out winnings, but also to issue invoices or payment orders for other participants in horse races, please note **that by signing an application form, applying owners, trainers and jockeys confirm the accuracy and completeness of their provided information (including their tax domiciles or VAT registration numbers), and are aware that they shall be liable to both other participants in horse racing activities and especially to financial authorities for any consequences which may result from a violation of their obligation to provide true and complete information for use by the Accounting Centre.**
